**THIS CAUSE** having come before the court upon the Joint Stipulation to Consent Judgment Awarding Attorney Fees and Costs to Defendant, it is hereby:

**ORDERED AND ADJUDGED** that:

1. The Court hereby finds, and the parties agree, that Defendant is entitled to recover a total of \$16,661.25 in reasonable attorney fees and taxable costs from and against the Plaintiff, and the Court hereby awards and adjudges said amount to and in favor of the Defendant, to be paid and satisfied by the Plaintiff, FELIPE ALAMO, **all for which let execution issue.**
2. Defendant is further entitled to post-judgment interest as of June 20, 2022 on the aforementioned balance awarded above (i.e., \$16,661.25) at the current, applicable rate of 4.25% per annum.
3. The Plaintiff has waived his right to appeal the Defendant's entitlement to reasonable attorneys fees.
